REPORT FROM CDP ALABAMA

Sgt. Lyn Giera was one of a few members of 2 Bn that participated in Homeland Security training at the Center for Domestic Preparedness (CDP) in Anniston, Alabama in December last year. The CDP is operated by the US Department of Homeland Security's Federal Emergency Management Agency and is the only federally-chartered Weapons of Mass Destruction (WMD) training facility in the nation. The CDP provides Federally funded, interdisciplinary training for emergency responders in Mobile Training Teams (MTTs) across the US and the US Territories, for 10 response disciplines: Emergency Management, Emergency Medical Service, Fire Service, Governmental Administrative, Hazardous Materials, Healthcare, Law Enforcement, Public Health, Public Safety Communications, and Public Works. SGT Giera and other participants in the training gained critical skills and confidence to be better prepared to effectively respond to local incidents or potential WMD incidents. HAM RADIO CLASS

SPC Ron Mesic (Acting Bn Comms NCO) coordinated a Ham Radio Technician License class that met at the Lincoln Park American Legion Hall on Saturday, January 22. The class was taught by Dave Metz and his wife Linda with assistance from SPC Mesic. The purpose of the class was to provide an overview of radio theory and electronics and then have members of the Motor City Radio Club administer the

actual test. Ham Radio operators have proven to be instrumental in assisting with communications during many actual emergencies. Often Ham radio operators are the only available means of communication after a major incident disables power, internet, and cell phone use. The FCC requires at minimum a Technicians License to become a radio operator. By upgrading to a General or Extra class license, an operator is allowed access to more frequencies and modes. The goal is to have numerous licensed Ham operators equipped with mobile radios within the ranks of the MiVDF in order to provide on site communications during a potential deployment.
